### **Works in Progress**

I am currently working on a co-authored book with Dr. David Carvounas which deals with socio-historically varying strategies for coping with precariousness and the effects these have had on temporality, on identity -formation and on Western European and North American cultural practices. Working title: *The Politics of Risk Society: From the Climate of Insecurity to the Culture of Immediacy*. Four out of a projected ten chapters have been completed, with one chapter published by *Time & Society*, and two others currently under review as book chapters for *Espaces Contestés*, edited by Simon Harel and Roxanne Rimstead (University of Ottawa Press) and *Contested Spaces: Conflict, Counter-Narrative, and Culture from Below*, edited by D. Beneventi and R. Rimstead (University of Toronto Press).

I have also completed two chapters out of a projected nine for my second book, which investigates the socio-economic role played in changing notions of cultural recognition in North-American and Western European identity politics from the eighteenth century to the present. Working title: *Recognition, Publics, and the Generalized Other: Towards an Archeology of Contemporary Cultural Politics.*

# **Teaching Experience**

Assistant Professor, Department of American Culture and Literature, Bilkent University, Ankara, Turkey Courses Developed and Taught (Listed alphabetically):

- 2005-12 *American Studies in a Global Context*. Advanced fourth-year undergraduate course also open to graduate students. Recent trends in identity politics and Cultural Studies are addressed as symptoms of larger conflicts stemming from both the globalisation of and resistance to neo-liberal economic policy.
- 2004, 7, 11 *Culture in its Historical Contexts:* Advanced fourth-year undergraduate course also open to graduate students. This course considers the eighteenth-century cultural and socio-economic origins of some of our contemporary notions of culture, individuality and collective identity. Particular focus is also placed on historically re-situating recent trends in subaltern, cultural and feminist studies by retracing their debt to the work of E.P. Thompson, Raymond Williams and the History Workshops of the 1960s and 1970s. The larger context of this course, however, can be summarised by one question: to what extent do cultural issues (whether in academia or within public discourse) gloss over rather than address the various socio-economic conflicts of the last three decades? In this regard, the influential work of Nancy Fraser, Charles Taylor, Honneth and Baumann on recognition issues are given particular consideration
- 2006 **Methods and Texts I.** Required core course for first-year undergraduates in American Culture and Literature. An introductory survey of cultural, cinematographic and literary theory. Stress is placed on developing the student's analytical and critical skills while at the same time fostering a historically informed understanding of current cultural issues such as identity-formation, ethnicity and nationalism.
- 2005-10 **Social Texts** After 1900. Required writing-intensive course for third-year undergraduates in American Culture and Literature. This course investigates aspects

of Western European and North-American self- understanding from the 20th century to the present, within a larger comparative non -Western perspective. Themes addressed include Social Darwinism, the Great Depression, Fordism, Keynesianism, the recent resurgence of Christian, Jewish and Muslim fundamentalist sects, the naturalisation of Neo-Liberal economic policy, and the social conflicts to which these give rise

- Social Texts to 1900. Required writing-intensive course for third-year undergraduates in American Culture and Literature. A critical introduction to the origins of Western European and North -American self-understanding and ideology. Topics investigated include notions of upward social mobility, technological innovation, and political rights—all of which are addressed in the eighteenth-century French, German, British and North American context of the philosophy of the Enlightenment, increased functional differentiation, the burgeoning Industrial Revolution and the consolidation of the nation-state.
- 2006, 12 *Topics in Cultural Studies.* Advanced fourth-year undergraduate course also open to graduate students. Pre-requisite: either of the two *Social Texts* courses. This course critically examines a cluster of concepts central to recent cultural theorizing (topics may vary) such as recognition, identity and agency, by retracing their changing conceptual history and by addressing their relation to the changing structure of the public sphere from the mid-eighteenth century to the present. In light of this critical and historical examination, students are introduced to recent issues in cultural inquiry such as those addressed by Charles Taylor, Nancy Fraser, Honneth, Habermas, Bauman, Beck, and Jameson.
- Topics in Theory. Advanced fourth-year undergraduate course also open to graduate students. An advanced introduction to aesthetic and cultural theory from Antiquity to the present, with particular focus on the economic and socio-historical context in which such theorising has been elaborated. Theories covered include Alexandrian philology, medieval hermeneutics, aesthetics from classicism and Boileau to Kant and Romanticism, Russian Formalism, North American pragmatism, phenomenology, structuralism, reception aesthetics, Marxist aesthetics, theories of the novel (Goldman, Lukács and Bakhtine), and recent trends in cultural studies.

- Introduction à l'interculturel (Introduction to the Inter-cultural). Department of Modern Languages. Required core course for graduate (MA and PhD) students in International Studies, also open to advanced undergraduates. An interdisciplinary introduction to recent debates on cultural issues and identity politics, and a survey of the historical origins of Western ideas about culture, identity and society.
- 2002-03 L'Avènement du monde contemporain (The Advent of the Contemporary World).

  Department of Philosophy. Required core course for first-year undergraduates in the interdisciplinary Liberal Arts program. A survey of various theories of modernity from the perspective of such disciplines as philosophy, sociology, economic history, aesthetics, and cultural/intellectual history.
- 2000-2 *Théories de la littérature.* Comparative Literature. Required core course for third-year undergraduates in Comparative Literature. This course examines the historical and social contexts in which literary and aesthetic theory has been elaborated from Antiquity to the present.

1996 *Les Problèmes de l'histoire littéraire.* Core course for upper-division undergraduates in Comparative Literature. I designed this course as an inquiry into the sociohistorical relations between the early nineteenth-century rise of literary historiography, the early development of the novel, and the consolidation of the modern nation-state.
